- **Heather Lukashin: Student Services Fee**

- Purpose: Heather Lukashin is here to inform SGOC about her intentions of wanting to raise the student service fee from \$4 to \$5.
- Q.) Do you have the 2014 fee currently brings in and cost are?
 - A.) Yes, I do have the historical data. In 2013, we went red; in 2015 we went red, went red in 2020, and in 2022. Currently we have \$270,124 in there; the expenses for 2022-2023 and 2024, we have all, but two areas built. One vacancy is the Ranger Newspaper, and the other is an hourly part-time MVP. We expect about \$689,340 to cover these expenses. However, where we stand with the students is \$316,181 but we are still short of what we need. Yet we can turn some other outlets, but even with the other outlets we will still be short; so, the raise from \$4 to \$5 will help fill the gap. The raise would come into place next year. Heather is confident that the enrollment will rise. Olympic College currently has 4,449 students as of the Winter quarter.
- Q.) You know how much of an increase it takes to break even?
 - A.) Yes, it is close to \$8.74, and I am unwilling to do that. I would rather keep scrambling for money than do that to the students. Heather is learning towards grant writing work.
- Q.) Why would you consider raising it to \$1 and not \$2?
 - A.) I look at the fee's students are given; she likes hunger for money. She doesn't want there to be a trust fund. The gap isn't drastic for students to cover, it isn't a sense of \$40-\$50 change but a \$1 change. From the SGOC student interest survey results, if students who are facing

- homelessness or food insecurity, that change can be a lot of money; and she doesn't want to do that for students.
- Q.) Are student service fees at all covered by FAFSA?
 - A.) Yes, it will be covered by FAFSA. It is the cost of attendance.
 - Q.) Because you are asking for another \$1 so technically \$5 now; will you ask for more money in the future?
 - A.) It depends on what happens in the country, if the inflation rate stabilizes, there will be a fine line point of not having to ask. If inflation keeps rising, then Heather will have to come back and ask again.
 - Q.) Do you have a list of the programs that are needed in the gap?
 - A.) No, I did not want to pinpoint exactly.
 - Q.) Do you have an idea of the current programs?
 - A.) I do, one of the things is the Career center. It was housed in Instruction but now it's moved to Student Affairs. It is 100% supported by Perkinson's money. Looking to get things supported by Instruction that does not need to be under Instruction out.
 - Q.) Where else are we getting the money to support that?
 - A.) She's the only Dean of the above; she has student advancement money from the state. Being smart with money when it comes to it. Advising budget from the state; has 17 budgets as of right now.
 - Q.) What is the time frame?
 - A.) All start next year, the 2024-2025 school year.
 - Q.) When and if this money does get passed, how would students know? Would there be a notice?
 - A.) Goes into action and gets posted on the website, all the increases go in on February 14th. It goes on public record with the BOT. By March, students will be able to know about the changes.
