Article I:

Section 2: "Include that they need ten Student Signatures in endorsement to apply for a Senate Position." **Edit:** Hiring process is conducted with the current SGOC Vice President, SGOC Advisor or other designee by the Student Affairs Dept.

Article II:

Section 5: "Members are nominated by the SGOC President and approved by Executive Council vote." **Edit:** One from each branch-senate exec council and club congress and 3 students at large.

Section 6: "All Executive Council members serve on this committee. Students at-large are selected by the SGOC Director of Finance and Operations" **Edit:** Six senate members plus Executive Council.

Article X:

Section 1: "4–6 students at-large (1 each from Shelton and Poulsbo; 2 from Bremerton if possible)" **Edit:** update to match. redundant article
