New Business:

→ Tatiane Simons: Budget Reallocation

→ SBA OC wants to allocate the funds of \$17,200 that was supposed to be used for a conference. They want to create a welcoming environment and the area needs an upgrade; with the enhanced environment it can help retain the success of students. The chairs in the room are not very comfortable and there are no adjustable desks.

A.) 36 chairs and 2 adjustable desks.

Q.) Will it go over budget?

MVP request part 2:

They had peer advisors out of Michigan connected with new mentors to help students with their degree. There was \$5,500, they wanted to allocate the funds to build a garden because they didn't have to pay for mentors. \$3,00 to be reallocated for a garden with the culinary (located behind Sophia learning center) and then \$2,500 for a sensory garden in the MVP courtyard.

- Q.) Would it go over budget by any chance?
- A.) Definitely a chance, haven't bought plants in a whole but we can do it within the baseline budget. But more positive on the fact that we will not go over the budget.
 - Q.) If ho do go over, what other funding?
- A.) If I feel that we will go over, I will ask the student affairs after for funding, but we will have to see.
